



Process – New – Sales – Installations

THIS DOCUMENT, WHICH IS NOT TO BE ALTERED OR CHANGED IN ANY WAY BY BOTH PARTIES AFTER THE CONTRACT, IS SIGNED INSTITUTES MAIN RULES. IT SUPERSEDES ALL PRIOR ORAL AGREEMENTS. IN THE CASE OF CONDITIONS AND CIRCUMSTANCES NOT COVERED BY THIS DOCUMENT ALL ADITIONAL MATTERS WILL BE ADDED TO THE QUOTE OR SALES AGREEMENT AND NEED TO BE AGREED BY BOTH SIDES BY SIGNING THE CHANGES.

- 1) A representative of Jacewicz European Windows Inc. will ask you for your window and door sizes.
- 2) We will present you with a quote, and upon your agreement we will ask you for a deposit of 40 % of the value of the sales agreement, and after that, we will send your order out for production. After the order is sent in for production, no changes and refunds are possible as all products are custom-made.
- 3) Before delivery, we will ask you for the additional 40 % value of the sales agreement. After delivery deposit funds are in Jacewicz European Windows Inc. we will schedule the delivery date. It is the client's responsibility to check the product for damage during delivery. This includes profile and glass. If any issues are noticed, they must be noted on the delivery form to be repaired or replaced under warranty claim.

PLEASE NOTE- DELIVERY WILL NOT BE SCHEDULED AND PRODUCT WILL NOT BE RELEASED BEFORE DELIVERY PAYMENT IS PROCESSED AND THE FUNDS ARE AVAILABLE IN JACEWICZ EUROPEAN WINDOWS INC. ACCOUNT.

- 4) It is the customers' responsibility to allow access to the place of work (snow, vegetation and another obstacle removal) Client needs to ensure parking space or city parking permits for our vehicles/trailers

- 5) To schedule the installation date, we will require the final amount of the contract value to be deposited in the Jacewicz European Windows Inc. account. After the payment is processed, we will schedule the installation date. There is a 65 cents/km fuel surcharge for trips during the installation process.
- 6) After the payment is received in full, ownership of the windows and doors is transferred to the customer, and your warranty takes effect.
- 7) There is a 5% interest charge, compounded monthly, on any unpaid balance.

PLEASE NOTE-DUE TO ANTI-FRAUD BANK REGULATIONS, IT CAN TAKE UP TO 10 DAYS (OR LONGER DEPENDING ON PAYMENT FORM USED) TO HAVE FUNDS AVIALABLE FOR THE ORDER. PLEASE KEEP THIS IN MIND WHEN ESTIMATING PRODUCT ARRIVAL TIME
